

MAJOR LAW CHANGE IN CALIFORNIA



February 2019



Effective January 1, 2019 the California State Legislators and the California Governor changed all trusts in California. The effect of SB 909 (as codified commencing in Probate Code 15901) permits a fiduciary of an irrevocable trust (i.e. a successor Trustee) to distribute property out of a first trust to one or more second trusts (which may be created under any jurisdiction) or modify the terms of the first trust without the consent of the

beneficiaries or approval of court, provided that the fiduciary has "limited distributive discretion" over the principal of the first trust for the benefit of one or more qualified beneficiaries. "Limited distributive discretion" is defined as discretionary power of distribution limited to an ascertainable standard or reasonably definite standard.

The second trust must grant each beneficiary of the first trust rights which are "substantially similar (i.e. no material change in a beneficiary's beneficial interest)" to their beneficial interests in the first trust. "Substantially similar" is defined as a distribution applied for the benefit of the beneficiary, on the beneficiary's behalf if the beneficiary is under a legal disability, or the distribution is made pursuant to the terms of the first trust instrument.

This new law applies to all existing and future trust governed by the law of California. If you don't want your successor Trustee to be able to modify your trust after your death you must now opt out of this new legislation.

INGREDIENTS

- 1 pkg Earthbound Farms
 Spring Mix
- 1 large cucumber, sliced
- 2 red peppers, seeded (tops and bottoms removed)
- 1 bunch radishes, sliced
- 1 small brick of partly skim mozzarella cheese
- 10 15 small plum tomatoes, halved
- 1/4 to 1/2 pkg Grab & Go Simply Sesame Trail Mix
- 1 bottle Kraft Roasted Red Pepper with Parmesan salad dressing

DIRECTIONS

- Place the Spring Mix in a large bowl. (If you can't find the Earthbound Farms Spring Mix just use a similar mixed greens blend, about 6 cups or more.)
- Using a small, heart shaped cookie cutter (about 1 inch) cut out heart shapes from the cucumber, red peppers, and mozzarella cheese.
- Sprinkle the veggies and cheese over the salad.
- Sprinkle with a generous amount of the Simply Sesame Trail Mix. (If you can't find this you can leave it off or substitute with another crunchy salad topper.)
- ♦ Just before serving, drizzle with your desired amount of Roasted Red Pepper Dressing and toss until equally distributed.
