

## Co-Trustees Can Pose a Problem

It is very common for clients to want to name their children as Co-Trustees in their estate plan, thereby allowing the children to be a check and balance to one another and allowing for accountability among multiple individuals. However, in recent years, banks have tightened their policies and many banks will no longer allow successor Co-Trustees to establish a trust account if the trust requires that they act jointly. The reason behind this is the banks do not want the liability that can arise when one Trustee writes checks on an account without the knowledge of the other Co-Trustee, when the trust expressly requires joint action. The banks don't want to be involved in enforcing the provisions of the trust, particularly the provisions that require "joint action".



Therefore, many banks now will only do business with multiple or Co-Trustees if the trust expressly states that the Co-Trustees are authorized to act separately with regards to financial transactions. If you have named multiple individuals to act as Co-Trustees, you

should consider naming them consecutively, as opposed to jointly – or- naming them together as Co-Trustees with the ability to act separately when it comes to finances. Otherwise, it is not uncommon for one of the children to have to resign as a Trustee, leaving only one Trustee to act, in order to continue business with the financial institutions.
