Farmhouse Style Decorative OrbsDIY

Here is what you need:

- 2 sets of 6-inch wood embroidery hoops
 (4 pieces in total)
- thumb tacks
- desired spray paint, craft paint, or wood stain





- Separate two sets of <u>embroidery hoops</u> and either paint, stain, or leave them as is if desired. You will have four separate pieces.
- 2. After they are completely dry, grab the two hoops with the metal locking mechanisms, and Intersect those two. Just place one inside the other.
- 3. Slide the other two hoops, one at a time, inside and move them around evenly so they form a sphere. Make sure they are going in the opposite direction as the first two hoops.
- 4. Manipulate the orb until you get the hoops evenly spaced and arranged how you'd like it.
- 5. Optional Step: Attach thumb tacks to each intersecting point. I like the look of the tacks, and I think it helps keep them in place, but this is up to you! You can also leave orb as is instead.

Tip: It helps to use a set of pliers to push in stubborn pins that may not go in easily.



HEALTHCARE DIRECTIVES ARE MORE IMPORTANT THAN EVER

During a pandemic, we are reminded constantly of just how important an Advance Healthcare Directive is. As even the young and seemingly healthy fall ill, it is more important now than ever to have a medical directive in place. An Advance Healthcare Directive is one of the simplest ways to ensure that your medical wishes will be followed, and that the people you trust will be involved in your healthcare decisions when you are unable to make those decisions for yourself. In an Advance Healthcare Directive, we include provisions regarding preferences for end-of-life treatment, such as life-support, pain and comfort treatment, and whether or not to be resuscitated. Another important healthcare document is the HIPAA authorization, which authorizes the release of your medical records and health history to your designated agents – without this document, it is against the law for hospitals and doctors to disclose this information to anyone.

While there might be many things outside of our control right now, having an Advance Healthcare Directive and HIPAA authorization is one thing that you can easily control. If you already have one, review it to make sure it reflects your wishes. Consider providing a copy to your children, or the doctor's office, and recommend your loved one's place a copy in their glove compartment for quick access. Bacon Wrapped Grilled Peaches

<u>Ingredients</u>

- 8 Strips Smoked Maple Bacon
- 2 ripe peaches (white, yellow, or 1 of each)
- Balsamic glaze
- Fresh basil, chopped



DIRECTIONS

- 1. Heat grill to med
- 2. Cut each peach into 8 wedges
- 3. Cut each bacon strip in half
- 4. Wrap each wedge with a half strip of bacon, secure with a toothpick
- 5. Place wrapped peaches on the grill, cooking first side until bacon is crisped to your liking and the peach flesh has browned and started to caramelize
- 6. Flip wedges and cook other side
- 7. Remove from grill and let rest 2-3 minutes
- 8. Arrange on serving platter, drizzle with balsamic glaze and garnish with a sprinkling of chopped fresh basil
